LIBRARIES and SCHOOLS



Challenges to comics and graphic novels in libraries and schools are on an alarming rise. CBLDF has been proud to dramatically increase our work to help fight these challenges by collaborating with librarians and associations and by creating tools to help increase the legitimacy of graphic novels as literature. By demonstrating the important place comics hold in 21st century literacy, our work helps librarians and teachers fight for comics.





LEGAL

Providing timely, expert legal defense is at the core of CBLDF's mission. Our commitment to this work is unwavering. In 2014, we rose to meet every First Amendment challenge we faced and successfully protected the comics community when emergencies arose.

Legal Counsel

CBLDF retains expert counsel to manage First Amendment emergencies. Our legal counsel, Robert Corn-Revere, is one of the country's most respected First Amendment attorneys. He has argued, and won, several landmark decisions, and successfully secured a posthumous pardon for comedian Lenny Bruce.

Preventative Assistance

Much of the legal work done by CBLDF is private. We spring to action at the first sign of a First Amendment emergency, referring artists to counsel, writing letters of support when needed, and stopping legal troubles before they become costly and public.



Defense Fund



For nearly 30 years, CBLDF has been dedicated to maintaining a legal defense fund, ready to be deployed when the First Amendment rights of comic stores, creators, and readers are attacked. This money is disbursed to pay for expert legal counsel when comics are targeted by unjust prosecution. Since 1986, hundreds of thousands of dollars have been raised and put to this good use.

Most recently, CBLDF has paid off all legal expenses related to our victorious support of Ryan Matheson, an American citizen unjustly prosecuted by Canada Customs for possessing manga.

Legislative Action and Amicus Briefs

CBLDF monitors legislation and challenges laws that weaken the First Amendment. Our amicus briefs fight precedent that erodes free speech. In one of our most celebrated moments, CBLDF's amicus brief in *Brown v. EMA* was cited by the Supreme Court in their decision, bringing the history of censorship in comics into the national judicial record.

EDUCATION

CBLDF maintains a robust education program that raises awareness of the rights guaranteed by the First Amendment and the dangers of censorship. We performed more education work in 2014 than ever before, including a vital publications program, school and library advocacy, and a record number of public events!

CBLDF Podcast

The Fund's monthly podcast brings the conversation about comics censorship to listeners everywhere with a lively mix of interviews, panel discussion, and archival materials that cover the full range of CBLDF's efforts protecting the freedom to read!

History of Comics Censorship

CBLDF provides an essential overview of comics censorship history. Covering incidents from the moral panic of the 1940s and 1950s that led to the Comics Code, to the attacks on comics retailers and artists that made CBLDF a necessity, and then to the modern era of censorship that targets comics readers, educators, and librarians, CBLDF's history of comics censorship is an important tool for students and enthusiasts alike.



News Coverage

CBLDF led this year's comics-focused Banned Books Week with this dynamic handbook, containing everything you need to celebrate the freedom to read comics! The handbook identified some of the most challenged comics and graphic novels and provided concrete tools to help fight book censorship, debunk banned books myths, and allow individuals to create anticensorship programming in their communities! More than 40,000 copies of CBLDF's handbook were circulated in comic stores, libraries, and schools across the country.

(Free Comic Book Day)



Detailing the basics of public, school, and academic libraries, the handbook explains the collection development process and offers suggestions for how creators and libraries can collaborate to develop events and programs.

BANNED BOOKS WEEK







CBLDF is a sponsor of Banned Books Week, Several prominent media outlets covere the annual celebration of the freedom to read. censorship challenges faced by comics:

Comics were the national theme of this year's Banned Books Week. CBLDF provided leadership by creating extensive resources, including our *Banned Books Week Handbook* and discussion guides for banned and challenged graphic novels.

Comics-focused Banned Books Week events happened all over the country, including a coast-to-coast CBLDF tour that involved Scott McCloud, Larry Marder, Brandon Graham, and Executive Director Charles Brownstein.

Several prominent media outlets covered censorship challenges faced by comics: Entertainment Weekly, The Guardian, Graphic Novel Reporter, Huffington Post, Kirkus, The New York Times, NPR's Morning Edition, Paste, Project Censored, Publishers Weekly, Reading Rainbow, Reason TV, and The Washington Post were just a few of the outlets covering comics censorship during Banned Books Week.

This year's Banned Books Week spotlighted comics censorship in a vital way, but with challenges to 12 books during the week, including new challenges to *Persepolis* in Oregon and Illinois, the battle is far from over.

ADVOCACY

CBLDF is on the forefront of Free Speech advocacy, through our homegrown efforts and as a partner in several vitally important coalitions protecting the First Amendment. These efforts help us fight unconstitutional laws, write letters of support when books are challenged, and advance education and advocacy that protects the right to read.

Media Coalition

CBLDF is a member of Media Coalition, an association that defends the First Amendment right to produce and distribute books, magazines, recordings, home video, and video games, and that defends the American public's First Amendment right to access the broadest possible range of information, opinion, and entertainment.




Kids' Right to Read Project

CBLDF is a partner in the Kids' Right to Read Project, alongside the National Coalition Against Censorship, American Booksellers Foundation for Free Expression, and the Association of American Publishers. KRRP offers support, education, and direct advocacy to people facing book challenges or bans in schools and libraries. KRRP has helped defend hundreds of titles from challenges in almost every state in the nation.

National Coalition Against Censorship

CBLDF is a member of the National Coalition Against Censorship, an alliance of more than 50 national non-profits, including literary, artistic, religious, educational, professional, labor, and civil liberties groups. As part of NCAC, we have engaged in direct advocacy and education to support First Amendment principles.

PUBLIC PROGRAMMING & EVENTS



CBLDF's staff and volunteer team is on the road year-round, providing lectures and workshops at comic conventions, book festivals, colleges, libraries, law schools, and professional conferences. We distribute our publications, provide education, and raise money at our convention booths. Your donation helps us stay in constant motion, spreading the word about free speech and doing outreach we otherwise wouldn't be able to do.

Lectures, Workshops, and Panels

In 2014, CBLDF staff delivered more than 40 public programs, including presentations on the history of the Comics Code, which had its 60th anniversary in 2014; banned comics; and using graphic novels in education, as well as workshops for librarians and educators. CBLDF's programs were presented at comics events all over the United States, as well as at the Berkeley Public Library, British Library, Chicago Public Library, Columbia University, New York University, Pace University, San Diego Public Library, William King Museum, and many other venues.

Convention Booth Education and Fundraising



CBLDF's efforts remain grassroots, with the majority of our education and fundraising occurring at conventions across the country. In 2014, CBLDF exhibited at 21 conventions, where we provided in-booth education to tens of thousands of readers and professionals about the current state of comics censorship. The convention booth is also a lifeline for CBLDF, providing the venue where we receive the majority of our donations and recruit the bulk of our members.

STAFF

CBLDF is run by a small staff that works full time, year-round, to protect the right to read. Between responding to First Amendment emergencies, developing educational content, giving public presentations, creating ongoing news and program content, and working with artists, stores, and publishers who aid our constant fundraising, we stay busy.
